Edenton Downtown Social District Management Plan

These provisions will be posted on the Town website and include a map of the district.

The Town of Edenton has designated the Edenton Downtown Social District (District) to allow citizens to enjoy alcoholic beverages in its newly revitalized downtown area. Signage will be posted in accordance with NCGS 18B within the district and at the district boundaries.

- 1) ABC permitted establishments must ensure they meet all legal requirements for carding and limiting consumption of alcoholic beverages. The establishment may only serve two beers/wine drinks or one liquor drink to one patron at a time.
- 2) No outside alcohol is permitted within the District. All alcoholic beverages must be purchased from establishments located within or contiguous to the District (in specially labeled cups) and must be consumed within the District.
- 3) Alcoholic beverages that are sold for consumption in the district may only be sold in a container that meets all the following requirements:
 - The container clearly identifies the ABC permittee from which the alcoholic beverage was purchased.
 - The container clearly displays the Edenton Downtown Social District Logo.
 - The container is not made of glass.
 - The container displays, in no less than 16-point font, the statement, "Drink Responsibly – Be 21."
 - The container cannot hold more than 16 fluid ounces.
 - ABC permit holders shall complete the acknowledgement form.

- All labels or cups shall be provided to the Town of Edenton for review prior to selling beverages within the District.
- 4) Upon leaving an establishment where an alcoholic beverage is purchased, the beverage must be consumed or discarded before entering a different business that serves alcohol.
 - 5) Businesses located within or contiguous to the district that do not serve alcohol may permit people to enter with an alcoholic beverage in an approved container.
 - a. The Town will provide window clings with the Social District logo and “Beverages Welcome” to businesses upon request. Participating businesses shall display the decal at all times when the social district is active. Businesses permitting patrons to enter with beverages shall allow law enforcement officers to access the premises accessible by customers.
 - b. Businesses not wishing to participate in the District should install signage indicating “Alcoholic Beverages Prohibited.” The Town will also provide window clings to these businesses on request.
 - 6) All alcohol in open containers must be disposed of before exiting the District or entering a vehicle.
 - 7) No alcoholic beverages may be brought into or consumed within the gated area of Colonial Park.
 - 8) Alcoholic beverages may be consumed in the District Thursday and Friday 5:00 PM to 9:00 PM and Saturday and Sunday 11 AM to 9 PM.
 - 9) Town of Edenton Police Officers will enforce the requirements of the District. The Town of Edenton reserves the right to prohibit a permit holder from participating in the district due to violations of the Social District management plan.

Example of Container Labeling for ABC Permit Holders

Containers must be non-glass and no more than 16 ounces. The required information may be printed directly on the container or on a sticker that is securely affixed to the container. The logo may be printed in one color to reduce printing costs. The text must be at least 12-point font.
