

## Courthouse Green Functions Temporary Street Closing Permit for Colonial Avenue

The use of the Courthouse Green for special events and functions may require the temporary closing of Colonial Ave to allow for the unloading of equipment to support functions. This application is for permit to temporarily close Colonial Avenue. Permits are not issued to temporarily close the 400 block of Court Street. There are three residential dwellings with driveways that have access to and from Court Street. Vendors are not permitted to block access to Court Street and the associated driveways. There are no driveways on Colonial Avenue therefore temporary street closings in conjunction with the special event will be considered for approval.
